 ✓ Right of Entry Form: Must be completed in full
 ✓ Agent Authorization: Must be completed in full if applicable
 ✓ Abandoned Well Search
 ✓ Subdivision Sketch or Tentative Plan

### **Requirements:**

- Legal description
- Proposed parcel dimensions
- Existing buildings, structures and distance from existing and proposed property boundaries
- Adjoining roadways
- Right of ways or easements
- Dimensions and areas for each proposed title

**Other:** If subdividing undeveloped land please check with the Town Planner to determine if other documents are required.
