You have filed an official complaint against a neighbor and have chosen the option of filling out this barking package with the anticipation of Town of Mayerthorpe issuing a summons to the dog owner or caregiver on your behalf. There are a few important things to note when you fill this package out. Please take a few moments to review this package prior to starting.

Please follow all steps when filling out this package. Provide <u>exact</u> information consecutively for 7-10 days, each time the dog(s) is barking. For example, <u>each</u> entry must have the date, start and stop time, location of animal, and conditions surrounding the animal. Please note that generic answers on this package such as "Barking all day" or "Dog lives down the road" is not acceptable and will be considered incomplete.

You may use additional paper if necessary and attach to the package. Completed packages may be returned to the Community Peace Officer for review as soon as it is completed. Incomplete packages will not be considered for review. Please note that there is no guarantee that a summons will be issued once this package is returned to the Town of Mayerthorpe. The decision to issue a summons for barking is ultimately made by the Community Peace Officer.
