Strategies (How)

- Have a sound municipal infrastructure plan and take action on the priority items. Infrastructure Plan has been incorporated into the Project Plan Projection and each year projects have been actions as prioritized by Council. The Asset Management - Phase II Project includes the updating of the Town's existing Infrastructure Plan for which funding has been confirmed.
- Ensure adequate core municipal infrastructure funding is available from municipal reserve funds, grant applications, and development agreements/contributions. Development Agreements include provisions for development security, land sales have included refundable deposits upon completion of conditions, many projects were undertaken as a result of grants received that were not contemplated nor budgeted, and Gasoline Alley North development agreement security enabled the completion of the Highway 22 and Highway 43 Traffic Lights, as well as Highway 22 intersection upgrades.
- Undertake paving and sidewalk enhancements when priority storm sewer pipe and drain upgrades are done. Achieved by completing paving of Gasoline Alley North development, Highway 22 Intersection Upgrade paving, paving of 42nd A Avenue and 45th Street, completion of \$510,000 in sidewalk replacements, griding of trip hazards, spot sidewalk repairs and replacements, ditching of alley between 46th and 47th Avenue, ditching and culvert repair along 50th Street north of 52nd Avenue, ditching and culvert repair along 54th Street, ditching along 48th Street and 52nd A Avenue, ditching and culvert replacements in alley between 50th and 51st Street north of 52nd Avenue, clean out of storm pond and drainage ditch at Lac Ste. Anne Foundation.
