BYLAW NO. 1182

BEING A BYLAW OF THE TOWN OF MAYERTHORPE TO AUTHORIZE THE MUNICIPAL COUNCIL OF THE TOWN OF MAYERTHORPE TO AMEND BYLAW NO. 1077 BEING THE NUISANCE AND UNSIGHTLY PREMISES BYLAW

WHEREAS, under the provisions of Division 7 of the Municipal Government Act, Revised Statutes of Alberta 2000 Chapter M-26, and Section 63(1) of the Revised Statues of Alberta 2000 R.S.A., a municipality may by bylaw authorize the revision of all or any of the bylaws of a municipality;

AND WHEREAS, the Council of the Town of Mayerthorpe determine it necessary to amend Town of Mayerthorpe Bylaw No. 1077 for the purpose of adding the definition of "Processing Fee";

AND WHEREAS, the Council of the Town of Mayerthorpe determine it necessary to amend Town of Mayerthorpe Bylaw No. 1077 for the purpose of amending fines to FINES AND PENALTIES, Section 5.5;

AND WHEREAS, the Council of the Town of Mayerthorpe determine it necessary to amend Town of Mayerthorpe Bylaw No. 1077 for the purpose of adding a subsection in ORDER TO COMPLY, Section 5.10;

NOW THEREFORE, the Council of the Town of Mayerthorpe in the Province of Alberta, duly assembled, hereby enacts as follows:

- 1. That the following be added to Bylaw No. 1077 DEFINITIONS Section 3.1:

 "Processing Fee" means a fee charged that reflects soft costs such as mailing, printing, papers, etc. incurred by the Town.
- 2. That Bylaw No. 1077, FINES AND PENALTIES, Section 5.5 (a) be amended to:
 - (a) \$300 for any offence with the exception of Section 5.11;
- 3. That the following subsection be added to Bylaw No. 1077, ORDER TO COMPLY, Section 5.10: (7) Where a person does not comply with the directions within a specified time, and the Town takes actions or measures required by the Order, all costs incurred by the Town to bring the property into compliance with the Order as well as a Processing Fee of \$25.00, will be billed to the Owner, and if not paid in the time specified by the Town, shall be added to of the ordinary municipal taxes. the tax roll as a charge against the Lands of the Owner in the same manner as taxes and with the same priority as to lien and to payment thereof as in the case.
- **4.** Should any provision of this Bylaw be invalid, then such invalid provisions shall be severed, and the remaining Bylaw shall be maintained.
- 5. That this Bylaw shall come into full force and effect on the date of the third reading.
