BYLAW NO. 1196

BEING A BYLAW OF THE TOWN OF MAYERTHORPE TO AUTHORIZE THE MUNICIPAL COUNCIL OF THE TOWN OF MAYERTHORPE TO ESTABLISH MISCELLANEOUS RATES OR FEES TO BE CHARGED FOR VARIOUS GOODS AND SERVICES PROVIDED BY THE TOWN OF MAYERTHORPE

WHEREAS, Section 6 of the Municipal Government Act, Revised Statutes of Alberta 2000 Chapter M-26 and amendments thereto gives a Municipality natural person powers, which imply the power to charge for goods and services provided,

WHEREAS, Section 61(2) of the Municipal Government Act, Revised Statutes of Alberta 2000 Chapter M-26 and amendments thereto authorizes a Municipality to charge fees, tolls, and charges for the use of its property, and

Short Title: This Bylaw may be referred to as the **MISCELLANEOUS RATES AND FEES BYLAW** of the Town of Mayerthorpe.

NOW THEREFORE, the Council of the Town of Mayerthorpe in the Province of Alberta, duly assembled, hereby enacts as follows:

- **1.** That the Goods and Services Tax (GST) will be charges on applicable goods and services as per Canada's *Excise Tax Act*.
- **2.** That the rates specified attached to this Bylaw may be modified and amended from time to time.
- 3. That this Bylaw shall come into full force and effect on the date of the third reading.
- **4.** That Bylaw No. 1175 and Bylaw No. 1183 be repealed.
